- 6:35 Welcome and introductions
- 6:39 **Board Action: Approve Minutes.** Eric motions to approve, Dan 2nds. Unanimous vote of approval
- 6:40 Leila Aman introduces **Foster Streetscape Plan**. Explains her role with Portland Development Commission and partnership with PBOT. She introduces Rich Newlands from PBOT.
- 6:42 Rich Newlands, Portland Bureau of Transportation Foster Streetscape Plan Project Manager, gives an overview of the streetscape plan which has potential of resulting in a 20%-50% decrease in crashes on SE Foster. That it is recommended from Federal Highway administration and is following PBOT's successes of other "road diets". Rich also presents that for years they have been looking for public input. Also explains that the complaints are a direct result of PDC & PBOT reaching out to address any questions or concerns. They are at 30% planning at this moment. He states that as they progress and hit 60% of planning phase, they will have another opportunity for community review and feedback. It is projected that 60% planning phase could come as early as July. Construction is planned to begin early 2017. Rich then answers questions from people in attendance.
